Dear Mr. Aitchison,

Through your past work with both the Muskoka Watershed Council (MWC) and the Town of Huntsville's Sustainability initiatives, you no doubt recognize the importance of a healthy watershed to the economy and identity of Muskoka. Since stepping down from MWC, we have appreciated your continued support and attendance at various events, including the 2019 Muskoka Stewardship Conference.

Knowing how integral a healthy environment is to our communities and economy, MWC was disappointed to learn that, for the second year in a row, our application through the District Municipality of Muskoka for Canada Summer Jobs funding for the Love Your Lake program was denied. Prior to the federal election in 2019, MWC had received at least partial funding for this program every year we had applied.

In addition to the Love Your Lake application, MWC was working with the Ontario Federation of Anglers and Hunters (OFAH) to obtain Canada Summer Jobs funding for an Invasive Species intern, one of several positions across the province. However, much to MWC's and OFAH's surprise, the Muskoka position was the only one in the province to not be funded.

We are reaching out to you for clarification on what the priorities are moving forward for the Muskoka-Parry Sound area. We would like to maximize the impact of MWC's limited resources by applying to programs that fund and support environmental initiatives. As the final decision on which Canada Summer Jobs applications receive funding in Muskoka-Parry Sound is made by your office, we are hoping you can help us better understand where we should be directing our efforts.

We would be happy to meet and discuss in further detail at your convenience.
