#### **Presentations**

Haliburton Forest & Wildlife Reserve - Peter C. Schleifenbaum, Principal Owner & Manager

Peter described his approach to private land stewardship on the 80,000 acre family business owned property located northeast of Stanhope. This area is the headwaters for three watersheds (Muskoka River, Ottawa River, and Trent-Severn River) and contains 60-70 lakes.

- Key element of his approach to stewardship include:
  - 4 pillars: recreation, resource management, research and education;
  - Peter's father bought the property in 1961. When the quality timber ran out they turned it into a recreational area to allow the timber resources to replenish;
  - Main focus today is forestry management, with tourism as a secondary focus;
  - Good relationship developed with Tembec for harvesting timber;
  - The first forest in Canada to receive FSC certification used as a pilot project;
  - Built own sawmill to process timber in-house in 2007;
  - Tourism represents approx 50% of the business; is declining in favour of forestry;
  - Have developed a program to manage the fisheries and lakes on the property; data is collected through partnerships with colleges and universities;
  - Forest is managed for long-term sustainability and encourages high diversity in order to make the forest more resilient:
  - Climate change is a major concern for the future management programs are focusing on promoting species that are expected to best weather climate change.

<u>Haliburton Highlands Water Trails</u> – Chris Card, Trails Technician/Bylaw Officer, Township of Algonquin Highlands

Chris described the unique programs in place to plan, operate and manage the water trails. Copies of the Hiking Trails Guide, the Frost Centre Canoe Routes Map, and the Haliburton Highlands Water Trails brochure were distributed.

#### Wake PSA

Lakes and rivers in Muskoka are fragile environments. Fish, wildlife, shorelines and shoreline structures like docks and boathouses are vulnerable to damage from boat wakes.

As a responsible boater, you should always be aware of the wake you create. When boating within thirty meters of the shore or in narrow channels, reduce your speed so you leave no wake.

Keep on top of things by making sure your system is inspected regularly and that your tank is pumped every three to five years. Learn and look for the warning signs that your septic system may be failing and take action immediately to protect your health and our water resources.
