  - 2.1. A Review of Successful IWM Approaches Around North America Sandra Cooke, Canadian Water Network

Sandra Cooke is the director of the Canadian Municipal Water Consortium at the Canadian Water Network (CWN). Prior to joining CWN, Sandra was the senior water quality supervisor at the Grand River Conservation Authority (GRCA), where she managed the conservation authority's watershed management plan. Sandra held a number of progressive leadership positions at GRCA and the Government of Alberta and she has a rich history of bringing municipalities and other water stakeholders together.

Through funding obtained from the Ministry of the Environment, Conservation and Parks, a team from CWN led by Sandra was retained by MWC in 2022 to study different models for watershed-scale governance that could be used to inform the development of a system of Integrated Watershed Management (IWM) for the Muskoka River Watershed. Sandra will be providing an overview of the findings of the Governance Study followed by a discussion of the current status of IWM in Muskoka.
