### Presentations

Limberlost Forest & Wildlife Reserve – *Gareth Cockwell*

Christy Doyle introduced Gareth, who presented a brief overview of the Limberlost Forest & Wildlife Reserve.

The Limberlost Forest and Wildlife Reserve is a publicly accessible private year-round wilderness area with twenty lakes and more than 10,000 unspoiled acres of mixed forest near Huntsville. The private forest reserve contains more than 70 km of hiking, biking, skiing and snowshoeing trails made available to the public at no charge.

Limberlost practices a form of land management called Conscientious Forest Management, which focuses on ensuring the sustainability of their management objectives and actions for generations to come. They encourage the use of the forest by visitors and eco-tourists at no charge; support environmental research programs and institutes; and offer both modern and traditional forest land use options to the local community.

Limberlost's primary objective is to offer continued free access to the 10,000 acre Muskoka property for the purpose of encouraging safe wilderness experiences. Free use of the property is made possible by revenue from rental accommodations and campsites.

After answering questions, Christy thanked Gareth for his talk. She also thanked the many volunteers and staff that make MWC's projects and programs successful.

### **MWC Working Group Initiatives**

MWC Working Group Co-chair Pete LeMoine highlighted the activities of the Working Group, which includes learning about the Simcoe Muskoka District Health Unit's Climate Change Story Map, the Algae Monitoring Program, and the planned communications initiative in local media featuring articles on watershed management and algae coordinated by Pete and Breeanna Campbell.

### **Updates & New Business**

- **Flood Task Force** – Kevin Trimble provided an update on the Flood Task Force struck by the Province and noted that he is compiling a list of media and outreach initiatives that include MWC. The communications initiative mentioned above will help promote MWC's message that a watershed strategy is needed for Muskoka.
- **Great Muskoka Paddling Experience** – Kevin Trimble noted that this is the first year the event will take place without Sandy Schofield at the helm. Sandy passed away in the spring, and the 2019 event will be held on Saturday, October 12<sup>th</sup> in his memory. Volunteers are needed to assist with the event, especially those with boats.
